GENERAL CONDITIONS

1. GENERAL PROVISIONS

Nautički centar Trogir d.o.o., Maksimirska 282, 10000 Zagreb (hereinafter: Organizer) organizes the Dalmatia Boat Show (hereinafter: Dalmatia Boat Show/Fair) in Marina Baotić, Seget Donji, Don Petra Špike 2a (hereinafter: Marina), in the period from 18.04. until 21.04.2024. Interested persons are legal and natural persons who, in accordance with the General Conditions, fill out the Application Form in order to participate in the Dalmatia Boat Show, about whom the Organizer has not made a decision. Exhibitors are legal and natural persons who, in accordance with the General Conditions, participate in the Dalmatia Boat Show.

2. APPLICATION AND PARTICIPATION

The right to participate in the Dalmatia Boat Show 2024 shall be granted to all legal and natural persons from the territory of the Republic of Croatia and from abroad who duly and timely complete the Application Form which also represents the Exhibition Agreement.

By submitting the Application Form, the Exhibitor confirms participation in the Fair and accepts all the conditions and prices of the Organizer. The Application form/Contract for Exhibitors shall be submitted to the Organizer no later than December 31, 2023.

The Organizer reserves the right to decide on the acceptance or rejection of each individual Application and to inform Interested Persons of its decision within 30 days from the date of receipt of the Application. On the basis of accepted Accessions/concluded Contracts, the Organizer will carry out the layout of the leased space on the Fair grounds.

The Application Form/Contract for Exhibitors is irrevocable and binding on the Exhibitor. All Applications for exhibition are only for registered legal and natural persons.

The registered Exhibitor does not have the authority to sublease the exhibition space assigned to him to another natural or legal person, and if he does so, he will be excluded from the Fair with the payment of double the fee for participation in the Fair. The exhibitor cannot assign the space to another legal or physical person without the consent of the Organizer.

Exhibitors undertake to submit to the Organizer a list of workers who will work on the leased space during the Fair, as well as contact phone numbers for easier communication, no later than 5 days before the Fair.

3. PAYMENT

Fair prices are based on the current Dalmatia Boat Show price list.

If the Application form/Contract for Exhibitors is accepted by the Organizer, the Organizer shall send the Offer containing all the selected services with the total price and payment information. The Exhibitor shall be obliged to pay all services no later than 7 days from the date of receipt of the Offer. Offers and/or invoices are delivered exclusively electronically to the e-mail address specified by the Exhibitor when filling out the Application Form.

All participation invoices issued by the Dalmatia Boat Show must be settled by the due date. Invoices for other services or deliveries that are ordered separately are due on the invoice date.

4. EXHIBITION AREA

The organizer undertakes to hand over the exhibition area and the ordered equipment no later than 24 hours before the start of the fair, and the exhibitor is obliged to bring all the exhibition items at least 18 hours before the opening of the fair. If the Exhibitor is unable to meet the deadline for any reason, he can request written approval from the Organizer to extend the deadline, and the Organizer decides on the same and informs the Exhibitor.

The exhibitor can arrange the exhibition area himself, in which case he is obliged to comply with the necessary standards and applicable regulations. Exhibitors as well as visitors to the Fair are obliged to comply with the provisions of the Port Regulations of Marina Baotić, which are an integral part of these General Terms and Conditions.

Exhibitors must take care of the management of their waste and dispose of it in accordance with the Plan for the reception and handling of waste and cargo residues from vessels and take care to respect the area of the Marina and all items that are in the Marina. The use of open flames, liquid gas, welding equipment and machines that generate sparks is strictly prohibited. There is a general ban on smoking in exhibition spaces and pagodas.

The Fair organizer ensures the cleaning of the fair area, conference tent and passageways. The exhibitor is responsible for cleaning the stands, which must be done daily before the start of each fair day. If the Exhibitor does not have its own cleaning staff, only companies authorized by the Fair Organizer can perform the cleaning. At the end of the Fair, the exhibitor undertakes to hand over the space and additional equipment to the Organizer in the condition in which he received them. Otherwise, the Organizer has the right to remove and store the goods at the Exhibitor's expense. The Exhibitor is obliged to pay for all damages that he may be caused.

5. PROMOTION AND SALES AT THE EXHIBITION AREA

The Exhibitor shall be entitled to display in the exhibition space only articles of which he is the manufacturer or the authorized representative and to promote partners of which he is the authorized representative. If the Exhibitor is unable to prove that it is authorized to sell the products and services listed in the Application, the Organizer reserves the right to prohibit the display of such products and services at the Fair.

The Exhibitor at the Fair may exhibit only the equipment and products indicated in the Application Form, consistently adhering to the provisions of the Application Form/Exhibition Agreement, with the obligation to submit no later than March 15, 2024, to the Organizer for approval a list of the services he intends to provide and the exhibits he intends to exhibit. The right to authorize the performance of any activities in the venue during the Fair (exhibition stand layout, catering, sales, recording, etc.) belongs exclusively to the Organizer.

The Exhibitor is obliged to sell the products listed in the Application Form/Contract for Exhibitors in accordance with the regulations and is responsible for ensuring that all exhibited products comply with the regulations and standards of the Republic of Croatia and the EU. For all non-compliant products, the Exhibitor is obliged to warn the visitor in writing. Any activity of the Exhibitor that interferes with other Exhibitors or visitors, as well as any form of political-propaganda activity, is prohibited.

6. WORKING HOURS OF THE FAIR

The opening hours of the Fair for visitors are from 18.04. to 21.04.2024 from 10:00 to 19:00. The Exhibitor is obliged to exhibit the declared exhibits from the opening to the closing of the Fair with the permanent presence of the responsible person at the exhibition area - the stand.

7. VEHICLE TRAFFIC

During the Fair, there is a general ban on parking inside the exhibition area. During the duration of the Fair, Exhibitors are allowed to enter the space only with a valid exhibitor card from 7:30 a.m. to 9:30 a.m. and after 7:00 p.m. The Exhibitor expressly agrees that the interior of the vehicle shall be inspected at all times by an employee of the Dalmatia Boat Show or his representative under the supervision of the Exhibitor or a person authorized by the Exhibitor.

8. LIABILITY AND INSURANCE

The Organizer is not responsible for damages or losses that may occur for any reason to vessels, vessel equipment and other exhibits - exhibits and personal belongings. The Exhibitor is responsible for damages that the Organizer or a third party would suffer from the use or holding of the vessel or other exhibit. The Exhibitor is obliged to insure his vessels and exhibits against liability with an insurance company and is obliged to ensure the safekeeping of his property himself.

Exhibitors exhibiting vessels and navigational equipment at sea are obliged to provide an authorized person trained to manage these vessels or navigational equipment outside of the working hours of the Fair. Therefore, any damage caused to all exhibition exhibits is the sole responsibility of the Exhibitor.

No liability is accepted for incorrect entries in the official catalogue of the Fair and/or other types of fair printing (printing errors, formal errors, etc.). The Organizer shall not receive shipments intended for the Exhibitor and is not responsible for possible losses, incorrect or late delivery.

9. SAILING / TESTING

Testing, trial and demonstration rides inside or outside the Marine area and aquarium are permitted only during the working hours of the Fair. The Organizer shall, for the sole purpose of ensuring the safety of persons, exhibits and equipment, reserve the right to decide on a temporary prohibition of dispatch, as well as the temporary storage of exhibited equipment, if unforeseeable circumstances or bad weather conditions so require.

10. POSSIBLE DATES CHANGES

The Organizer undertakes to inform the Exhibitors in a timely manner about all relevant changes in the organization of the Fair due to unforeseen circumstances. Exhibitors cannot claim compensation from the Organizer for such changes.

11. CANCELLATION OF PARTICIPATION

In the event of the Exhibitor's cancellation of participation, the Organizer retains 100% of the bid amount.

12. EVENT CANCELLATION

The Organizer is obliged to deliver the contracted services at the event to the Exhibitor. If the Organizer is unable to hold the event due to its cancellation, the Organizer shall refund to the Exhibitors 100% of the funds paid into their account. Exhibitors shall not be entitled to claim compensation for any additional costs or damage that may be incurred as a result of the cancellation of the event, nor shall the Organizer be obliged to compensate for them.

13. ACCREDITATION - OFFICIAL PASS

The rules on the issuing and use of official accreditations shall be adopted by the Organizer and shall be communicated to the Exhibitor in a timely manner, and the number of accreditations shall depend on the area of the space rented. An official pass shall be issued in the name of a person accredited by the Exhibitor and who is the sole authorized user. The exhibitor shall complete the application for accreditation and submit it to the Organizer by 1 April 2024 at the latest. In case of late submission of the application, the Organizer reserves the right to charge for the accreditation according to the applicable price list. If there is an abuse of accreditation, the Organizer may refuse to provide services, and the person who has abused it will be permanently removed from the Fair.

14. PHOTOS, AUDIO, VIDEOS AND ADVERTISING MATERIAL

The Organizer shall be authorized to take photographs and make other types of video and audio recordings freely in the given exhibition spaces during the Fair and to use them for his own and general needs. Exhibitors shall, in this respect, waive any copyright and claims and shall not themselves have the authority to make such recordings without the specific authorization of the Organizer, except within their own exhibition area.

15. BREACH OF OBLIGATIONS

In the event of a breach of any of the rules set out in these General Terms and Conditions, the Organizer shall be entitled to terminate the Contract without the possibility of a refund or complaint.

16. FINAL PROVISIONS

These General Terms and Conditions are drawn up in Croatian and English, and in the event of a dispute or doubt regarding the interpretation or application of certain of its provisions, the Croatian version shall prevail. In the event of a dispute arising from a violation or misinterpretation of the provisions of the General Conditions, Application/Contract, Application form, etc., the Organizer and the Exhibitor mutually agree to the jurisdiction of the Commercial Court in Zagreb. The law of the Republic of Croatia is applicable. The Organizer reserves the right at any time to amend or supplement the General Terms and Conditions of Business, as well as the right at any time and without prior notice to amend, supplement or terminate any part of its business. The amendments shall enter into force on the day of their publication. The Organizer undertakes to notify the Interested Persons and Exhibitors of any amendment to the General Terms and Conditions to the email address provided by them when filling out the Application Form.

17. PRIVACY POLICY
